THIS COURT MADE TWO REASONS  
FOR ITS DECISION:

① IT STATED THAT IT WAS  
RELYING ON REVENIGATION.

② IT WAS RELYING ON MOTIONS FILED IN BC321524.

AS TO REUTICATION, THIS COURT DID NOT TAKE INTO CONSIDERATION THE FACT THAT FRAUD UPON THE COURT - ADMITTED BY DEFENDANTS - DOES NOT CONSTITUTE REUTICATION UNDER CALIFORNIA LAW.

AS TO MOTIONS IN BC321524, AT THE TIME THIS COURT RULED ON THE MOTIONS - IT DID NOT FIND THEY WERE MOTIONS THAT FELL WITHIN CCP391. FURTHER - THERE WAS NOT A BASIS THAT WAS RELIED BY DEFENDANTS IN THEIR NOTICE OF MOTION AND ON ITS OWN MOTION, THE COURT CANNOT USE THIS AS A BASIS.

③ THIS COURT SPECIFICALLY STATED IT WAS NOT RELYING ON THE FEDERAL ACTIONS.

④ THIS COURT DID NOT MAKE ANY FINDINGS ON THE CALIFORNIA CASES AND DID NOT BASE ITS DECISION ON THEM.

⑤ THIS COURT DID NOT FIND PLAINTIFF DOES NOT HAVE ANY REASONABLE PROBABILITY OF SUCCESS THIS TRANSCRIPTS REFLECT THE CONTENTS OF THIS OBJECTION PLAINTIFF HAS ORDERED THE TRANSCRIPTS AND WILL SUPPLEMENT


FINDING CANNOT BE MADE BECAUSE
